RESOLUTION #17-03-35 APPROVAL OF MINUTES OF THE REGULAR SESSION OF THE TOWN OF METIS-SUR-MER HELD ON FEBRUARY 6, 2017

ADOPTION OF REGULATION #17-107 - CLOSURE AND ABOLITION OF PARCELS OF LAND AS A PUBLIC WAY

CONSIDERING THAT the Government of Quebec has already transferred to the former municipality of Métis-sur-Mer the management of the former right-of-way of a road as it appears from the notice of the Official Gazette on April 22, 1950 and November 4, 1961. Part of this former road is described and confirmed in the certificate of location prepared by Mr. Michel Asselin, of December 15, 2016, under the number 11 686 of its minutes attached to this document.

CONSIDERING THAT this part of road is no longer used for traffic;

CONSIDERING THAT the closure of this part of road causes no prejudice to anyone;

CONSIDERING THAT a notice of motion was given at the regular session on February 6, 2017;

ACCORDINGLY:

It is proposed by Councillor Mr. Raynald Banville and resolved unanimously that the Council of the Town of Métis-sur-Mer adopts this By-law as presented to the members of the Council.

6.2 To sell for \$1.00 a part of the former road to Mr. Richard Martin and Ms. Brigitte Morin.

<u>RESOLUTION #17-03-38</u> TO SEII FOR \$1.00 A PART OF THE FORMER ROAD TO MR. RICHARD MARTIN AND MS. BRIGITTE MORIN

CONSIDERING THAT these parcels of land have been closed and abolished as a public way in 2017 by regulation #17-107;

FOR THIS REASON,

It is proposed by Councillor Ms. Martine Bouchard and resolved unanimously that the Council of the Town of Métis-sur-Mer agrees to sell for \$1.00, parts of land described in regulation # 17-107 closure and abolition of parcels of land as a public way as well as on the plan prepared by the surveyor Michel Asselin, minute #11 686 and appoints the Mayor and the Director-general to sign all documents related to this case.

6.3 Credit demand for public water service taxes at 336, route 132.

RESOLUTION #17-03-39 CREDIT DEMAND FOR PUBLIC WATER SERVICE TAXES AT 336, ROUTE 132

Whereas this business is closed since fall of 2014;

WHEREAS the municipality without having been advised by the owner that the business has been closed, has continued to apply its regulations on tariffs of aqueduct for this kind of business;

WHEREAS the Council received a request from the owners dated February 1, 2017, wanting a tax credit on the water service of the building;

Whereas in the event of the reopening of the commercial establishment, the municipality must be notified immediately by the owners and the municipality will adjust the tax rates immediately and charge the owners according to the months remaining in the year.

FOR THESE REASONS,

It is proposed by Councillor Mr. Simon Brochu and resolved unanimously that the Council of the Town of Métis-sur-Mer allows the Treasurer to apply a credit of 3.75 units of water taxes according to the tariff in force in 2015 and in force in 2016 on the tax account with the assessment number 6691-17-6020. The credit amount is in an amount of \$ 1 367.89 for 2015 and \$ 1 141.66 for 2016 for a total of \$2 509.55.

7.1 Permit for intervention on roads of the MTQ for 2017.

RESOLUTION #17-03-43 PERMIT FOR INTERVENTION ON ROADS OF THE MTQ FOR 2017

CONSIDERING THAT the municipality must execute some work close to the roads under the maintenance of the *Ministère des Transports*;

CONSIDERING THAT the municipality is responsible for work executed by its employees;

CONSIDERING THAT the municipality wants to respect the clauses of the intervention permits emitted by the *Ministère des Transports*;

CONSIDERING THAT the municipality wants to give back to the *Ministère des Transports* the road infrastructures in their original state;

CONSIDERING THAT it is necessary to obtain an intervention permit from the *Ministère des Transports* to intervene on the roads under its responsibility;

CONSIDERING THAT the municipality asks *le Ministère* to give to the Town, permission to perform all unplanned emergency work, to be done between January 1 and December 31, 2017;

CONSIDERING THAT the municipality asks *le Ministère* to not require a deposit for all estimated costs to rehabilitate the right-of-ways not exceeding ten thousand dollars (\$10,000);

IT IS PROPOSED by Councillor Mr. Raynald Banville and resolved unanimously that the Council of the Town of Métis-sur-Mer requires from the *Ministère des Transports* the intervention permits for work which will have to be executed in 2017 and authorizes Mr. Frédéric Richard, Director of public works, to sign the intervention permits.
