**RESOLUTION #17-07-125**

**ORIENTATIONS GOUVERNEMENTALES EN AMÉNAGEMENT DU TERRITOIRE (OGAT)**

**CONSIDÉRANT QUE** le Gouvernement est présentement en consultation sur le renouvellement des orientations gouvernementales en aménagement du territoire (OGAT);

**CONSIDÉRANT QUE** les futures OGAT auront un impact majeur sur la planification du territoire québécois pour les 15 à 20 prochaines années;

**CONSIDÉRANT QU'**une présentation de la démarche de renouvellement des OGAT s'est tenue à Rimouski le 29 mai dernier;

**CONSIDÉRANT QUE** la présentation du MAMOT lors de la rencontre du 29 mai dernier annonçait des OGAT plus souples et adaptées au contexte rural;

**CONSIDÉRANT QUE** les projets de documents des futures OGAT mettent en lumière un très faible diagnostic des milieux ruraux, qui ne représente pas notre réalité rurale éloignée des grands centres urbains;

**CONSIDÉRANT QUE** le contenu des futures OGAT vise principalement des enjeux urbains, voire métropolitains;

**CONSIDÉRANT QUE** les futures OGAT demandent que soit mis en place des pôles régionaux et d'y concentrer tous types de développement au détriment des autres municipalités;

**CONSIDÉRANT QUE** les futures OGAT exigent 136 actions obligatoires pour les MRC afin de se conformer, et ce, dans des champs de compétences municipaux inédits, voire dépassant les compétences réelles établies par le cadre juridique en vigueur;

**CONSIDÉRANT QUE** les exigences des futures OGAT en matière agricole sont démesurées et peu justifiées, notamment dans les milieux ruraux périphériques;

**CONSIDÉRANT QUE** les futures OGAT vont augmenter de manière très importante la lourdeur administrative déjà présente, notamment lors des modifications ou révisions de schéma d'aménagement et de développement;

**CONSIDÉRANT QUE** les futures OGAT vont à l'encontre de l'esprit de la nouvelle loi 122 visant principalement à reconnaître que les municipalités sont des gouvernements de proximité et à augmenter à ce titre leur autonomie et leurs pouvoirs;

**CONSIDÉRANT QUE** le calendrier actuel de consultation et les courts délais impartis aux MRC du Bas-Saint-Laurent rendent difficiles toute analyse en profondeur des documents d'orientation ainsi que toute participation significative à leur renouvellement;

**CONSIDÉRANT** les élections municipales du 5 novembre 2017.

**POUR CES MOTIFS :**

Il est proposé par M. le Conseiller Simon Brochu et résolu à l'unanimité :

**QUE** la Table des préfets du Bas-Saint-Laurent :

1) signifie son insatisfaction auprès du ministère des Affaires municipales et de l'Occupation du territoire eu égard au contenu des nouvelles orientations gouvernementales en aménagement du territoire;

2) demande à ce même ministère de prolonger la période de consultation au moins jusqu'en janvier 2018 sur le renouvellement des OGAT afin traverser la période des élections municipales et de permettre à l'ensemble des MRC et municipalités du Bas-Saint-Laurent d'analyser les implications de ce nouveau document;

3) demande à ce même ministère de reconsidérer son approche en aménagement du territoire pour les milieux ruraux périphériques, notamment en créant des OGAT distinctes pour ces milieux

ou en améliorant significativement la modulation des OGAT selon la typologie réelle des territoires du Québec;

4) demande qu'une nouvelle consultation régionale sur le contenu des OGAT soit réalisée à la suite de la prise en compte des différentes préoccupations régionales et municipales exprimées.

5) diffuse la présente résolution pour adoption auprès des différentes MRC et municipalités du territoire bas-laurentien et du Québec.

**CONSIDERING THAT** it is requested in this letter that 2<sup>nd</sup> Range needs to be paved and the municipality makes sure that the speed limit is respected;

#### **FOR THESE REASONS,**

It is proposed by Councillor Mr. Raynald Banville and unanimously resolved,

**THAT** the Council cannot commit to pave this road because of the absence of financial support;

**THAT** the Council is committed to reducing the dust caused by the traffic by applying the dust control materiel on a regular basis;

**THAT** the Council will acquire a digital speed board and thus workers will be able to install it in this area for a period to be determined by them.
