ADOPTION OF BY-LAW #17-119 - CONCERNING THE CODE OF ETHICS AND GOOD CONDUCT OF ELECTED MUNICIPAL OFFICIALS OF MÉTIS-SUR-MER

10.2 Municipal support for school perseverance days.

RESOLUTION #18-02-29

MUNICIPAL SUPPORT FOR SCHOOL PERSEVERANCE DAYS

WHEREAS Bas-Saint-Laurent area has chosen to place school perseverance among the four regional priorities of COSMOSS in order to mobilize around this issue all the partners of the territory and meanwhile this problem is closely linked to other issues, including the image of our territory, the migration stability, the succession and qualification of labor, social development, public health and the fight against poverty;

WHEREAS school dropouts have significant negative impacts on economy, estimated at 1.9 billion dollars annually throughout Quebec;

WHEREAS even though Bas-Saint-Laurent has the best graduation and lowest school dropout rates in Quebec, there are 76.2% of students under the age of 20 who obtain a first degree, i.e. 68.9% of boys and 83.6% of girls. There is, therefore, work to be done to achieve the new 85% target set by the government in the new policy on educational success;

WHEREAS the prevention of school dropouts does not concern exclusively the school environment, but is a social issue which must be addressed collectively from early childhood until the young person obtains a qualifying diploma for employment;

WHEREAS Bas-Saint-Laurent has developed, through the *Démarche COSMOSS*, a culture of considerable commitment to preventing school dropouts, and that this collaborative force is recognized at the provincial level;

WHEREAS the *Démarche COSMOSS* organizes school perseverance days and these days aim to be a strong period of the year showing both local and regional mobilization around the prevention of school dropout and these days will be filled by activities in different communities of the eight MRC's in our area;

FOR THESE REASONS,

IT IS PROPOSED BY COUNCILLOR MS. MARTINE BOUCHARD AND RESOLVED UNANIMOUSLY THAT THE COUNCIL OF MÉTIS-SUR-MER,

- Declares the third week of February as school perseverance days in our municipality;
- Supports the efforts of COSMOSS partners mobilized to fight school dropout with people working in education, politics, local and regional development, health, research, media and business sectors to make our MRCs to be territories of educational value as a real development lever for their communities.
