3. OPEN VARIA.

3.1 Hiring for public works.

A resolution has been adopted by the Town to hire Mr. Steeve Fougère from Métis-sur-Mer for public works. His working conditions will be determined in the contract that will be signed between the two parties. The Mayor is named as a signatory for and on behalf of the Town.

3.2 Project of By-law 18-128 concerning the circulation of trucks and heavy vehicles.

Notice of motion has been given at the Council that at a further meeting will be adopted By-law #18-128 relating to the traffic of trucks and heavy vehicles. The draft regulation deposited at this meeting aims essentially to control the traffic of heavy vehicles on the roads of Métis-sur-Mer.

3.3 Installation of septic system at the lighthouse.

WHEREAS the Town has proceeded with tenders by invitation to two contractors to install septic facilities at the lighthouse location;

A resolution has been adopted by the Town to give the contract to Les Entreprises D'Auteuil of St-Ulric to install two wastewater treatment systems and landscaping after work in the amount of \$ 35 116.42 before taxes. This amount will be paid by the grant received for the acquisition of the lighthouse.

3.4 Installation of a ventilation system at the lighthouse.

WHEREAS the Town requested a tender to a company specializing in ventilation to correct the problem of ventilation in the lighthouse as presented in the health booklet,

A resolution has been adopted by the Town to give the contract to Refrigeration Air C of Rimouski to install an adequate ventilation system as presented in the health booklet in the amount of \$ 6 350 before taxes. This amount will be paid by the grant received for the acquisition of the lighthouse.
