5. OPEN VARIA.

5.1 Professional fees for the MRC engineering service for the retaining wall.

A resolution has been adopted by the Town to authorize the payment of professional fees for the engineering department of the MRC de la Mitis – retaining wall project in an amount of \$ 7 466.38 from the accumulated surplus not reserved.

5.2 To name signatories for the signing of the emphyteutic lease with the ARPP.

A resolution has been adopted by the Town to appoint the mayor and the director general to sign all necessary documents concerning the long-term lease between the Town and the Association des résidents de la pointe du Phare de Métis-sur-Mer regarding the management of the Pointe-Mitis lighthouse site.

5.3 Offer of professional services – geotechnical study – outlet in St. Lawrence – (TECQ 2014-2018).

A resolution has been adopted by the Town to accept the offer of professional services of the firm Englobe Corp for a geotechnical study relating to the replacement of a waste water outfall in an amount of \$ 4 975 plus applicable taxes, N/ref.: 2018-P073-0320. This project is eligible for TECQ 2014-2018.

5.4 Minor derogation requested for 205 Route 132.

The application is aimed to allow a rear setback of 1.7 meters for an existing main building in the 22ILD zone, contrary to the regulation which provides a minimum rear setback of 12 metres for a main building in the 22ILD zone.

CONSIDERING THAT the request meets the objectives of the urbanism plan;

CONSIDERING THAT the authorisation of such request for a minor zoning variation does not affect the enjoyment by the owners of the neighbouring buildings of their right to property;

CONSIDERING THAT the application of the regulation causes serious injury to the applicant;

CONSIDERING THAT the application is for an already constructed building;

CONSIDERING THAT the application is covered by an article of the zoning regulations that may be the subject of a minor zoning variation;

FOR THESE REASONS,

A resolution has been adopted by the Town to accept the request for minor zoning variation demanded and specified in the public notice.

5.5 Authorization requested for the Garden Party of August 7, 2018.

A resolution has been adopted by the Town to give permission to persons responsible for the Garden Party to cross and circulate on the public way, with golf carts, from Cascade Golf Club to the residence of Ms. Lesley Stowe and Mr. Geoffrey Scott, 346 rue Beach, for this charitable activity. This authorization is valid only for the day of August 7, 2018 or in case of rain on August 8, 2018.
